Call for selection, by titles and possible interview, for n. 1 post-graduate scholarship for research activities entitled: “Development project for Paralympic sports with a particular focus on winter sports: from strategies to improve performance to those aimed at enhancing inclusion and accessibility” **scientific disciplinary sector MEDF-01/B - Methods and didactics of sports activities.**

DECREES

Art. 1 - Institution and financiers

The selection procedure, by titles and possible interview, for the conferment of n. one (1) renewable research grant entitled “Development project for Paralympic sports with a particular focus on winter sports: from strategies to improve performance to those aimed at enhancing inclusion and accessibility” under the guidance of the Scientific Director, Prof. Federico Schena. The grant is activated for the performance of activities of particular and specific importance in the field of scientific research relative to the development of Paralympic sport. It is financed with external funds, intended to support scientific research activities. Fund: SCHENA_MANNI_DONAZIONI (CTB LIBERALE PER RICERCA Prof. Schena)

Project and aims:

The research project aims to examine the validity of functional classification systems, with the goal of ensuring fair and balanced competitions. Additionally, it seeks to develop strategies to enhance the visibility of Paralympic winter sports through events, media, and communication campaigns, thereby encouraging the participation of people with disabilities in sports.

The research fellow will be tasked with designing and conducting experimental research phases under the guidance of the Scientific Supervisor, as well as processing the collected data and producing the corresponding scientific results. At the same time, they will be responsible for creating multimedia content for social platforms, aiming to reach and engage the widest possible audience, promoting inclusion and accessibility in Paralympic sports.



Art. 2 - Duration, amount and legal nature of the exchange

The grant will last 6 months, starting from March 1st, 2025, possibly renewable (if appropriate funding is found), subject to the authorization of the Department Council on the proposal of the Scientific Manager and/or holder of the fund.

The exchange, for an amount of 11.000, 00 euros (eleven thousand/00) will be paid in monthly installments postponed according to the activity carried out. For intermediate periods, other than the first day of the month, the first installment will be adequately proportionate and paid with the second monthly installment.

Coverage against risks deriving from civil liability towards third parties and accidents, which could occur during the period of attendance of the university facilities as well as outside them, provided that it is documented by written and reasoned authorization of the Scientific Manager, within the limits provided for by the general policy of the University. The expenses of such an insurance policy will be deducted directly from the purse amount.

From the month of the beginning of the research activity, the grant will be disbursed for the (100% in monthly installments) 90% (ninety percent) in monthly installments net of the annual insurance premium of 10.00 euros. The remaining 10% (ten percent) of the amount will be disbursed after the presentation of the final report on the activity carried out by the holder of the scholarship.

The enjoyment of the scholarship referred to in this notice does not constitute, in any way, an employment relationship (full-time or part-time) or autonomous, being aimed solely at the training of the holder of the scholarship.

The exchange will not give rise to social security and welfare treatments, nor to legal and economic evaluations or awards. The scholarship is exempt from personal income tax pursuant to Article 4, paragraph 3, of Law 3 July 1998 n. 210 which provides for the application of the IRPEF exemption regime referred to in Article 6, paragraph 6, of Law no. 398 of 1989, in addition to doctoral scholarships also to scholarships awarded by Universities for postgraduate research activities, as confirmed by the Revenue Agency with Resolution no. 120/E of 03 November 2010.

The scholarship cannot be combined with other scholarships or forms of subsidy, except for those provided for surcharges for stays abroad.

In the case of a self-employed or subordinate or parasubordinate employment relationship, compatibility will be certified by the Scientific Manager.

Art. 3 - Recipients

Will be considered as preferential qualifications:

- A curriculum suitable for carrying out the activities in question;
- Previous experience in sports activities related to Paralympic sports and strategies for promoting and including adapted sports;
- Knowledge of the English language



Foreign citizens are admitted to the selection if they provide equivalent qualifications and a scientific-professional curriculum suitable for the specific research activity.

In the event that the candidate is not in possession of the equivalent title, the application must be accompanied by documents useful to allow the Selection Committee to decide on the request for eligibility of the title (e.g.: list of exams taken in the course of studies) and the curriculum.

The above requirements must be met on the date of expiry of the deadline for submitting applications for admission to the selection. Candidates are admitted to the selection with reservation.

Those who have a degree of kinship or affinity, up to and including the fourth degree, with the Rector, the General Director, a member of the University's Board of Directors or with a professor belonging to the Department of Neuroscience Biomedicine and Movement (pursuant to Article 18 of Law 240/2010) cannot participate in the selection.

Art. 4 - Method of submission of the application and deadline

The application for participation in the selection must be drawn up in free paper, according to the attached scheme that is an integral part of this call (ANNEX 1), signed by the candidate, must be submitted **by 1.00 PM 20 February 2025** by Certified E-mail (PEC), in .pdf format, at the address ufficio.protocollo@pec.univr.it. If the candidate does not have a personal PEC address, the application transmitted by an uncertified e-mail address will also be considered valid. The subject of the e-mail must be the following: "Application for participation selection **Cod. Sel. DIPNBM INCLUSION ENG 2025**".

Any other form of submission of applications is excluded.

The Administration assumes no responsibility in the event that the files transmitted by e-mail are not readable. The Administration also assumes no responsibility for the dispersion of communications, dependent on inaccurate indications of the delivery by the competitor or failure or late communication of the change of the address indicated in the application, nor for any misunderstandings in any case attributable to third parties, fortuitous events or force majeure. They must be attached in a single readable file in .pdf format (ANNEX 1):

- a) scientific-professional curriculum
- b) list of degrees obtained (e.g., specializations, certificates of attendance of postgraduate courses, obtained in Italy and/or abroad, scholarships or research assignments both in Italy and abroad, etc.) and the publications for which it is intended to request their evaluation for the purposes of the competition, produced by non-authenticated photocopy and accompanied by the declaration of conformity to the originals or self-certification made pursuant to articles. 46 and 47 of the D. P. R. 445/2000, taking care to include all the useful elements in order to ensure the correct evaluation and verification of the attached titles. For this purpose, candidates may use the form attached to this call (ANNEX 2)
- c) copy of a valid identity document. Certificates for which evaluation is requested must be produced within the deadline set for the submission of applications.

In application of the rules on self-certification, the University reserves the right to carry out appropriate checks on the veracity of substitute declarations and self-certifications. If the controls indicated above reveal the non-truthfulness of the content of the declarations, the declarant loses any benefits resulting



from the provision issued on the basis of the untruthful declaration, without prejudice to the provisions of Article 76 of Presidential Decree no. 445/2000.

Art. 5 - Selection and allocation of the grant

Candidates ' applications will be reviewed by the Selection Board, appointed by the Department and composed as follows:

- Prof. Federico Schena, Full Professor, SSD MEDF-01 / B - Methods and didactics of sports activities - PRESIDENT
- Professor Chiara Milanese, Associate Professor, SSD MEDF-01 / B - Methods and didactics of sports activities-COMPONENT
- Professor Barbara Pellegrini, Associate Professor, SSD MEDF-01 / B - Methods and didactics of sports activities-COMPONENT
- Professor Chiara Zoppirolli, Associate Professor, SSD MEDF-01 / B-Methods and didactics of sports activities – ALTERNATE

For the evaluation, the Selection Committee will have 100 points for each candidate, of which 40 for the qualifications and 60 for the interview, as follows:

Title rating (maximum score 40 points):

- up to 15 points: titles and equivalent qualifications
- up to 25 points: preferential titles

Will be subject of the interview (maximum score n. 60 points):

Item	Points
Knowledge of the topics related to the call for applications.	up to 25
Expertise in research methodologies and editorial and multimedia activities in adapted sports.	up to 20
In-depth skills in strategies for the promotion and inclusion in adapted sports.	up to 15

During the interview, the knowledge of the English language will be verified.

The assessment of the titles takes place before the interview.

Candidates who have obtained a score for titles equal to or greater than 25/40 points will be admitted to the interview. The interview is considered passed if the candidate obtains a score greater than or equal to 35/60 points.

The selection is considered passed if the candidate obtains an overall assessment of no less than 60 points, considering titles and interview.



The Selection Committee will meet on 25.02.2025 1.00 PM via ZOOM.

Candidates must present themselves at the interview with a valid identification document.

Once the selection has been completed, the results will be announced to the candidates by the Selection Committee, after the interview. The Selection Committee will draw up a special report with the criteria, the reasoned results of the evaluations and the identification of the merit ranking expressed in cents. The document shall be immediately enforceable.

The award of the scholarship takes place on the basis of the merit ranking, formulated by the Selection Committee and posted at the aforementioned examination site as well as by publication on the University's website in the SCHOLARSHIPS/RESEARCH section of the page <https://www.univr.it/it/concorsi>

The candidate who won the scholarship will have to plan the start of the activities with the Scientific Manager and will be contacted by the Secretariat of the Department of Neuroscience Biomedicine and Movement before 28.02.2025 to define the acceptance of the scholarship and the presentation of the expected substitute declarations.

In the declaration of acceptance, the scholarship holder must acknowledge that he has read "The Regulation for the activation and allocation of research grants funded by public and private entities" of the University of Verona.

In the event of non-acceptance or forfeiture by the right holders, the candidates who have subsequently placed in the ranking of merit formulated by the Selection Committee take over.

Art. 6 – Exclusions

By order of the Director of the Department, candidates who do not meet the requirements set out in Article 3 of this call will be excluded. It will also be excluded those who submit the application after the deadline indicated in the previous article 4, or without subscription or without the documentation to be presented in accordance with the same article. Exclusion can be arranged at any time.

Art. 7 - Rights and duties of fellows

Fellows can access the research facility to which they are assigned and take advantage of the services available to researchers in accordance with the regulations in force in the facility. The research activity will be carried out inside the structure as well as outside it, where necessary and expressly authorized by the Scientific Manager.

The scholarship holder who, after starting the research activity in the program, does not continue it, without justified reason, regularly and continuously for the entire duration of the scholarship or who is responsible for serious and repeated non-compliance, may be declared forfeited from further enjoyment of the scholarship. The forfeiture measure will be adopted by the Director of the Department on a reasoned proposal from the Scientific Manager.

The scholarship holder must, at the end of the duration of the scholarship, transmit to the Department a detailed report on the activity carried out to allow the Selection Committee adequate evaluation. In case of publication of the results of the research carried out during the period of enjoyment of the stock



exchange, the author must indicate the assignee and the funding body of the stock exchange thanks to which the research was carried out.

Art. 8 – Safeguard rules

For what is not provided for in this call for selection, reference is made to the provisions of the law on the subject as compatible and to the Regulations for the establishment and award of grants for research activities referred to in the foreword.
