- since 2000: researcher by contract at the Faculty of Law of the University of Verona; then (since 2002) as researcher in tenure-track - disciplinary field IUS/15 "Civil Procedure Law"; then (since 2006) as a tenured researcher;
- since 2002: participation at the conferences of the Italian Association of Civil Procedural Law and at several conferences on Civil Procedural Law; participation as a lecturer at several conferences and seminars organized by Professional Associations (Bolzano, Milano, Verona e Trento), Private Entities (Unione Camere Minorili, AIAF, Euroconference), Training and Specialization Schools (Neg2Med);
- since 2000 to 2002: Tutor of the School of Specialization in Legal Professions of the University of Verona and Trento;
- since 2002 to 2007: Professor of Civil Procedure Law at the School of Specialization in Legal Professions of the University of Verona and Trento;
- since 2007 up today: assistant Professor granted with teaching courses in Civil Procedural Law, Labour Procedural law and Civil Procedural Law – advanced level;
- since 2007 to 2013: member of the Board of Ph.D in Law and Business Economics – domestic and international disciplines – at the Faculty of Law of the University of Verona;
- 2017: Professor of Course for Barristers and Solicitors about "Amministrazione di sostegno" for Bar Association of Verona and of the Course for Barristers and Solicitors about "Tutela del minore" for Bar Association of Verona;
- since 2018 to 2024: Professor of Civil Procedure Law at the School of Specialization in Legal Professions of the University of Milan;
