PROFESSIONAL EXPERIENCE

October 1st 2018 – today

UNIVERSITY OF VERONA – PHD STUDENT

From October 1st 2018 I am a PhD student at the University of Verona under the supervision of tutors Prof. Tommaso dalla Massara and Prof. Carlo Pelloso. My PhD project concerns the problem of the problem of the sanctioning function in civil liability in cases of serious personal injuries, with particular attention to the problem of deterrence. Starting from the reflection on the function of civil liability provided by Pandektenwissenschaft, through the analysis of the origin of the problem in Roman law as the basis of the common European legal tradition, the aim is to deal with the modern debate on the problem of the *quantum* and the reason of quantification of personal injuries. Special attention is paid to European Private Law and especially to the concept of proportionality, which is found in many judgments dealing with the issue of recognition of punitive damages in Europe. Finally, the research intends to distinguish between the civil penalty found in various continental legal systems, which respects the principle of proportionality, and punitive damages.
