WHEREAS

- the right to education is understood and interpreted by the signatories to this MoU as being universal;
- refugees and asylum seekers are massively hindered in their access to higher education, with only 7 % of refugees worldwide having access to university studies;
- the signatories to this MoU are interested in and committed to implementing services and actions for social integration, in the education sector and in the business field;
- it appears necessary to further strengthen the system of safe and regular pathways as an instrument of protection for refugees who cannot return to their countries of origin;

- after the pilot experience managed by University of Bologna, UNHCR, Caritas Italiana, Ministry of Foreign Affairs and International Cooperation, together with other partners, that in 2019 launched the first edition of the UNI-CO-RE project (University Corridors for Refugees, Ethiopia-Unibo 2019-21) that conducted to the arrival of five refugee students in September 2019, in the past 6 years, 45 universities joined this model offering more than 250 scholarships to refugee students living in different countries;
- with the New York Declaration of 19 September 2016 and in the context of the Global Compact on Refugees of December 2018, the international community has assumed the responsibility for increasing complementary pathways for refugees in an organized, systematic and sustainable manner;
- in the Three-Year Strategy (2019-2021) on Resettlement and Complementary Pathways, UNHCR recommends the adoption of new partnerships with institutions working in the field of education and training to implement new refugee entry channels and strengthen existing ones;
- University of Bologna, together with other Universities, submitted relevant pledges in the context of the two Global Refugee Forums organized in December 2019 and December 2023; in addition, during the last Global Refugee Forum, a further pledge was submitted in favor of UNICORE project by Fondazione Finanza Etica aimed at implementing financial services in support of UNICORE beneficiaries and of their financial inclusion needs in Italy;
- in its proposal for a new Pact on Migration and Asylum and in the Recommendation of 23 September 2020 (*Commission Recommendation on legal pathways to protection in the EU: promoting resettlement, humanitarian admission and other complementary pathways*), the European Commission recommended implementing new complementary pathways for the regular and safe entry and protection of refugees and persons in need of international protection, such as study and work programmes;
- the Minimum Standards on Complementary Education Pathways for Refugees developed by the Global Task Force on Third Country Education Pathways and the UNHCR Policy paper “Education 2030: A Strategy for Refugee Education”;
- the “Third Country Solutions for Refugees: Roadmap 2030 The next phase of the Three-Year Strategy on Resettlement and Complementary Pathways (2019-2021)”;
- the present protocol is drawn up in compliance with the provisions of Law 241/1990, art. 1 paragraph 1 bis insofar as it is applicable to the parties.

IT IS MUTUALLY AGREED AS FOLLOWS

Article 1 (Object)

The parties undertake to cooperate in order to implement the seventh edition of the University Corridors for Refugees project, aimed at allowing 67 refugee students to enter Italy regularly for university enrolment in two-year Master’s degree programmes [Annex 1: Project Proposal: **University Corridors for Refugees, UNICORE 7.0 (Ethiopia, India, Kenya, Malawi, Mozambique, Namibia, Niger, Nigeria, South Africa, Tanzania, Uganda, Zambia, Zimbabwe 2025-27)**].

University corridors are activated in favour of students who currently live and have been recognized as refugees in Ethiopia, India, Kenya, Malawi, Mozambique, Namibia, Niger, Nigeria, South Africa, Tanzania, Uganda, Zambia, Zimbabwe and are highly motivated to pursue university studies in Italy.

All the above-mentioned universities will select students in Ethiopia, India, Kenya, Malawi, Mozambique, Namibia, Niger, Nigeria, South Africa, Tanzania, Uganda, Zambia, Zimbabwe.

This protocol aims at carrying out the following activities:

- disseminate the University Corridors initiative (2025/2027) within the refugee student community in Ethiopia, India, Kenya, Malawi, Mozambique, Namibia, Niger, Nigeria, South Africa, Tanzania, Uganda, Zambia, Zimbabwe;
- select refugee students in Ethiopia, India, Kenya, Malawi, Mozambique, Namibia, Niger, Nigeria, South Africa, Tanzania, Uganda, Zambia, Zimbabwe who hold or are about to obtain (within the deadline of the individual calls for applications, see below) a degree, suitable for admission to Master's degrees, through merit-based and transparent procedures;
- facilitate regular entry into Italy for refugee students by obtaining visas for study purposes and university enrolment;
- support students during the admission process, during the master's degree course and in the job inclusion phase;
- provide financial support, in the stages of obtaining a visa, including eventual need of Declaration of Value or equivalent comparability documentation (CIMEA certificate), and entry into Italy and for at least the normal duration of the study programme (2 years);
- promote the integration of refugee students into local life.

Article 2 (Roles and commitments)

UNHCR and the universities listed above are the promoters of the project and will coordinate its activities.

The parties will participate in the project with the following commitments in the different phases:

- Promotion of the project and selection of students

UNHCR, Caritas Italiana (in countries where they are present through their branches) undertake to promote the initiative among refugee students' communities in Ethiopia, India, Kenya, Malawi, Mozambique, Namibia, Niger, Nigeria, South Africa, Tanzania, Uganda, Zambia, Zimbabwe;

UNHCR will be in charge of updating the website (<https://universitycorridors.unhcr.it/>) for the uniform and systematic dissemination of the calls for proposals prepared by each university and will develop information material, social card, info leaflet, also in paper form, for the dissemination of the initiative in Ethiopia, India, Kenya, Malawi, Mozambique, Namibia, Niger, Nigeria, South Africa, Tanzania, Uganda, Zambia, Zimbabwe, directly or through local partners or through the refugee community in Italy; in addition, UNHCR will assist potential applicants in submitting the applications, by providing technical support (laptop, connectivity, transportation, etc.), if required.

UNHCR will host the project's website which will allow Students, UNHCR Operations and Universities to log in and manage their workflow in the platform in order inter alia to record applications and proceed with the selection process until the finalization of the selection. Moreover, UNHCR undertakes to verify that the admissibility requirement of the refugee status of each applicant is confirmed;

The Universities that activate corridors for the foreseen period undertake to prepare a specific call aimed at selecting refugee students based on the submitted documentation (that includes academic curriculum and curriculum vitae, motivational letter/video and any other documentation required by the individual academic call) and online interviews;

- Pre-departure activities

The parties identified below undertake to implement the following activities:

MAECI: expedited processing of applications for the issuance of entry visas for study purposes on the travel documents of the selected candidates and of the documentation required for university enrolment, including the *Dichiarazione di Valore*, when possible and expressly requested by universities;

UNHCR, Caritas Italiana and Gandhi Charity: accompaniment and logistical support to students, facilitation of administrative processes in Ethiopia, India, Kenya, Malawi, Mozambique, Namibia, Niger, Nigeria, South Africa, Tanzania, Uganda, Zambia, Zimbabwe;

UNHCR, Caritas Italiana, Diaconia Valdese and Gandhi Charity: medical examination of beneficiaries (if required), logistical and/or economic support for visa applications and/or pre-departure activities;

UNHCR, Caritas Italiana, Diaconia Valdese: coordination for organization and purchase of flights to final destination in Italy for all the selected students. Universities who committed to pay the flights, through their own funds, for students who will be awarded the scholarships are the following: Polytechnic University of Bari (2), Polytechnic University of Marche – Ancona (1), University of Eastern Piedmont, Vercelli (1), University of Parma (2), University of Trento (1).

UNHCR and Caritas Italiana (in countries where they are present through their branches): accompaniment and logistical support to students in Ethiopia, India, Kenya, Malawi, Mozambique, Namibia, Niger, Nigeria, South Africa, Tanzania, Uganda, Zambia, Zimbabwe. Facilitation of administrative processes.

UNHCR: support to facilitate online interviews and to obtain the travel documents and other documentation necessary for entry into Italy for the selected students¹;

UNHCR, Caritas Italiana, Diaconia Valdese and Gandhi Charity: provide with information to the students on rights and responsibilities related to the visa for study purposes and on the communication of the project; pre-departure cultural orientation of the selected students; individual interviews to become acquainted with the beneficiaries' social and health situations.

The University for Foreigners of Siena and, the University for Foreigners of Perugia will offer totally 80 hours of linguistic assistance in Italian (via synchronous and asynchronous distance learning, as appropriate) in July/August/September 2025 to selected students who request it and who are leaving for Italy. The activity is free of charge. Upon specific request of the Universities signatory to this Protocol,

¹ India is not party to the 1951 Refugee Convention or its 1967 Protocol. However, it continues to grant asylum to a large number of refugees as, in the absence of a national legal and administrative framework, UNHCR, based in New Delhi, conducts refugee status determination (RSD) for asylum-seekers from non-neighbouring countries and Myanmar. Convention Travel Document is therefore not issued by the local authorities and UNICORE students selected from that country will eventually travel with alternative travel document (e.g. national passports, if they already possess one).

similar activities may be envisaged, subject to specific agreement, at a subsidized cost even after arrival in Italy.

- Admission to degree programme and administrative procedures upon arrival in Italy

Universities activating the corridors in their seventh edition undertake to offer guidance and support to students in the admission and enrolment phases of their study path. Selected students should follow ad hoc rules foreseen in each call to complete his/her enrollment.

- Financial support upon arrival and during the study period in Italy

Universities participating in the project, Diaconia Valdese, Caritas Italiana (through the diocesan Caritas), Centro Astalli: scholarships, food/canteen and accommodation services, socio-legal and psychological assistance, registration with the National Health Service or a form of private health insurance, issue and renewal of residence permits, pocket money, season tickets for transport (in the absence of *ad hoc* agreements), socio-health support, purchase of PCs/books (if necessary), clothing, and other activities to integrate students into Italian families that can act as support. The distribution of services and costs related to the stay and integration of students in Italy, listed above in a non-exhaustive manner, may be provided for and detailed in specific local protocols promoted by the individual universities with the diocesan Caritas agencies involved, the Diaconia Valdese and Centro Astalli.

These protocols may also involve other partners, subject to prior communication to UNHCR and MAECI. This Protocol shall be referred to in the individual local protocols and form an integral part of them.

UNHCR shall coordinate the activities related to the communication of the project in order to ensure uniformity and consistency in compliance with the rights of the selected students and of the parties to this Protocol, also through support to the universities' individual press offices.

The actions aimed at achieving the objectives of the project will be agreed in detail by its promoters in accordance with the Project Proposal (Annex 1).

If necessary, the parties will be able to agree on different modalities and timeframes with respect to those set out in the Project Proposal.

Article 3 (Costs)

Each party undertakes to cover the cost of the activities expressly assumed under Art. 2 pursuant to this Protocol and possibly also set out in the local protocols agreed with the individual universities.

Further forms of support not currently indicated may also be envisaged by each of the project partners, which shall in any case be communicated to the other signatories of this Protocol in order to allow for overall monitoring of the initiative.

This Protocol and the implementing measures shall not entail any new or additional financial burden for MAECI or the administrations it oversees.

Article 4 (Duration of the project)

The project aims to ensure the enrolment of students in A.Y. 2025-26 in master's degrees and to provide support to beneficiary students for the academic years 2025-26 and 2026-27.

Article 5 (Monitoring)

With the aim of constantly improving the project, the Parties agree on the importance of constant monitoring through inter alia regular coordination meetings (in person or remotely), also in order to assess the effectiveness of the initiative, in accordance with the methodologies used by UNHCR.

Article 6 (Duration)

This Protocol shall be valid and effective from the date of signature by the parties and shall last until 30 April 2028 (except for Luiss University for whose validity is up to 31 July 2027) for the implementation of activities according to the timetable set out under art. 4.

This Protocol may be renewed in writing by exchange of letters between the Parties, via PEC.

Any party may withdraw from the Protocol by written communication via PEC, to be sent at least three months in advance. The withdrawal will not affect the activities already agreed and funded.

Article 7 (Amendments)

Additional universities or partners may join this Protocol, in order to contribute to the project, set out in art. 1 to support and integrate the activities listed in art. 2, by means of a letter countersigned for acceptance by the signatories of this protocol.

Article 8 (Contact persons)

For the activities pursuant to this Protocol, the Parties appoint the contact persons listed in Annex 2.

Each Party undertakes to promptly notify the other Parties of any changes. Communications between the Parties shall be made through the designated contact persons by means of institutional e-mail, except in cases where the use of PEC is expressly required.

Article 9 (Applicable law, definition of disputes and competent court)

This Protocol shall be governed by Italian law with respect to the activities of the Parties, which shall be bound by the laws of Italy and, with respect to UNHCR, to the extent that such laws are applicable without prejudice to the privileges and immunities of UNHCR or of the United Nations under the 1946 Convention on the Privileges and Immunities of the United Nations, customary international law, the Agreement between the Government of the Italian Republic and the United Nations High Commissioner for Refugees concluded on 2 April 1952.

The Parties agree to settle amicably any dispute arising out of, or in any way connected with, the interpretation and/or implementation of this Protocol.

Any dispute or claim arising out of or in connection with the interpretation, application or implementation of this Protocol, including its existence, validity or termination, between UNHCR and any other Party to the Protocol shall be settled amicably by negotiation or by other non-judicial means of dispute settlement, in particular the United Nations Commission on International Trade Law ("UNCITRAL") Conciliation Rules then in force; the language of the conciliation procedure shall be English unless otherwise agreed by the Parties. If the dispute is not resolved within sixty (60) days after the date of service of the request for conciliation by either party, the dispute shall be submitted by either party to an arbitral tribunal in accordance with the UNCITRAL Arbitration Rules then in effect. The arbitral tribunal shall consist of a single arbitrator and the language of the arbitral proceedings shall be English unless otherwise agreed by the parties. The arbitrator shall not have the authority to award punitive damages or to award interest, in

respect of any period of time, at a rate higher than the base rate fixed by the Bank of England during the relevant period (such base rate not being in any event less than zero) and the interest awarded shall be simple interest only. The arbitration procedure will take place in Geneva (Switzerland), headquarters of UNHCR. As far as possible, the proceedings shall be conducted remotely (in writing or by video conference).

Article 10 (Immunities and privileges of UNHCR)

Nothing in this Protocol shall be deemed to constitute a waiver, express or implied, of the privileges and immunities of UNHCR or of the United Nations under the 1946 Convention on the Privileges and Immunities of the United Nations, customary international law, the Agreement between the Government of the Republic of Italy and the United Nations High Commissioner for Refugees concluded on 2 April 1952, other international agreements, and relevant national legislation, including Law No. 114 of 14 February 1994.

Article 11 (Processing of personal data)

The parties undertake to process - as controllers - the personal data conferred by the students solely for the purposes related to the execution of the UNI-CO-RE University Corridors for Refugees 7.0 (2025-2027) project, in compliance with Legislative Decree 30/6/2003, no. 196, Legislative Decree 10/08/2018, no. 101 and Regulation (EU) 2016/679 of the European Parliament and of the Council of 27 April 2016 on the protection of individuals about the processing of personal data and on the free movement of such data and repealing Directive 95/46/EC (General Data Protection Regulation). UNHCR will also comply with the conditions set out in the Policy on the Protection of Personal data of persons of concern to UNHCR, UNHCR/HCP/2015/6 (Annex 3).

UNHCR undertakes - to the extent of its competence as data controller - to process personal data provided by students for purposes related to the implementation of the UNI-CO-RE University Corridors for Refugees 7.0 (2025-2027) project, in application of and in compliance with its own internal rules and procedures on data protection which reflect the principles set out in this respect by European legislation, in particular the Policy on the Protection of Personal Data of persons of concern to UNHCR, UNHCR/HCP/2015/6 [https://www. Refworld.org/pdfid/55643c1d4.pdf](https://www.Refworld.org/pdfid/55643c1d4.pdf)).

For the procedures aimed at the admission of students to the study programmes of the universities taking part in the project, the data controllers are exclusively the aforementioned universities.

Article 13 (Signature, amendments, registration and expenses)

The present Protocol is drawn up by means of a private deed (with digital signature of the parties or handwritten) in English. Amendments to this Protocol may be approved in writing, by exchange of letters between the Parties, via PEC (certified electronic mail).

This Protocol is subject to registration only in the event of use in accordance with current legislation, at the expense of the requesting party.

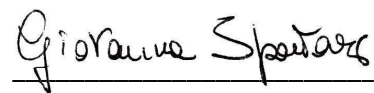

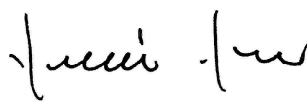
